



## Brief on CTTC Bhubaneswar :

Central Tool Room & Training Centre (CTTC), Bhubaneswar has been established under the Technical Co-operation programme between the government of India and Denmark as a Govt. of India Society. The management of affairs of the centre rests with the Governing Council constituted by Ministry of MSME, Govt. of India. The centre started functioning in 1991 with the Training department followed by Production in the year 1994. The centre has emerged as one of the pioneer institute & technology centre of world class in India having state-of-the-art machines and equipment.

## Background of the RPL Project :

For empowering and upliftment of the state youth, CTTC Bhubaneswar was approved by Ministry of Skill Development and Entrepreneurship (MSDE) for implementing Special MSME RPL training program in which training target of 50,000 by NSDC, New Delhi was sanctioned for training to Rural youth on Pan Odisha basis as per the NSQF approved job role.

The key objective of this project is to undertake Recognition of prior learning (RPL) along with Bridge course and certification of both organized and un-organized workforces working across the state of Odisha. CTTC Bhubaneswar conducts Bridge training along with Recognition of Prior Learning (RPL) as a solution to the skill gap in 09 job roles of various sectors. NSDC, New Delhi monitors the programme for the implementation of RPL and Bridge training.

The centre has completed training of 18000 candidates in the 01<sup>st</sup> Phase of the project in the following job roles :

## **Purpose of RPL Impact Assessment Study :**

Impact Assessment aims at assessing the effectiveness of the programme post implementation of RPL-Bridge training by CTTC in the FY 2019-20. The data collected as part of the survey should allow for the measurement of the impact of the RPL-Bridge scheme on key socio-economic parameters. The study will be an independent study conducted by a third party agency to give an objective assessment of the impact and to develop case studies in each of the district where training is being implemented by the centre under the project.

The study will focus on the key parameters mentioned below (not limited to):

1. Social transformation
2. Employability
3. Social Status
4. Productivity and Efficiency
5. Knowledge and Skills

## **Scope of work under the RFP**

The selected agency will be responsible for the following :

### **Preparatory Arrangements :**

Agreement with CTTC on the dates of the study, movement plan, logistic support, deployment of key staff and other arrangements. This will also include preparation of tools (questionnaires/forms/templates) as per approval of CTTC.

### **Recruitment and Training of Field Staff :**

Recruitment, orientation of its impact assessment team.

### **Sample Selection :**

The agency should draw a representative sample of 10% of candidates trained in each location. Within this sample following parameters should be well represented :

- a. Job roles for which RPL was conducted
- b. Gender ratio
- c. Block/District where program is implemented

## **Field Study**

Meeting all the relevant stakeholders involved in the RPL Project. Following are some of the key stakeholders in the RPL Training program implemented by CTTC :

1. Trainers
2. Employers
3. CTTC Officials
4. Village/Institution Head where the RPL with Bridge course implemented
5. Assessors
6. Mobilization team

### **Data points to be captured:**

Following data points for the sample defined and through stakeholder's meetings to be captured:

(Note: the below list is not exhaustive, other appropriate parameters to be included) :

- a. Total no. of candidates enrolled, trained and certified under the program.
- b. Candidate profile: Gender, education qualification, age, social group, income etc.
- c. Analysis: Pre and Post program implementation.
- d. Income change (if any).
- e. Feedback.
  - i. Candidates feedback on effectiveness of training.
  - ii. Post training employment opportunity and feedback of employers
- f. Develop appropriate questionnaires/ forms/templates for data collection
- g. Data Entry
- h. Prepare case studies: Identification of champions among the candidates trained and capture their lives transformation in form of a case study. The agency will be responsible to work out at least 2 case studies per district. These case studies will be showcased as impact stories of the program.
- i. Data Analysis: Analysis of data using appropriate tools and software.
- j. Preparation of Reports: Preparation of reports and presentation in the desired format to CTTC.

## Duration of Engagement

The impact study is to be completed within 2 months from the date of agreement between CTTC and Selected Agency. The impact study should include minimum 30 days of field tour and information collection, interview of the trainee successfully completed training, field visit report and analysis. The final report, result sheets along with the complete data set for each survey shall be submitted within the stipulated 2 months period along with suggestions and improvements for the project.

- c) Must have dedicated human resources with relevant experience in field study, supervision data enumeration and project management.
- d) Should have valid PAN and GST number.

The Technical evaluation will be based on profile and track record of agency, past experience of similar nature & magnitude. Only the technically qualified proposal will be considered for financial bid.
